Notes: *Italics* indicate tentative meeting dates. Meeting dates for 2027 will be established at the February 12, 2027, meeting; Deadline dates are the first business day after 75 or 90 days when the 75th or 90th day falls on a weekend or holiday.

A National Register of Historic Places nomination is a complex set of materials and preparing one can be a lengthy process that typically takes between twelve (12) and eighteen (18) months. A nomination often goes through several drafts and reviews by SHPO staff before it is complete and ready to be presented to the State Historic Preservation Review Board. We encourage you to plan for 45-60 days of SHPO review time per draft (backlogs may necessitate additional review time). The time required for SHPO reviews can be shortened by reviewing and using applicable NPS and SHPO guidance and by submitting a “technically and professionally correct and sufficient” nomination. We encourage all preparers to contact SHPO staff with questions as soon as they arise and to make use of [General Guidance and Requirements for National Register of Historic Places Nominations in Michigan](#), Michigan’s guide to the National Register program, when preparing a nomination and reference that document throughout the nomination process. Complete nomination packages **must be received by 4:00 pm** on the respective deadline date noted below.

SHPO requires complete and final nominations to be submitted **ninety (90)** calendar days before a State Historic Preservation Review Board meeting for Certified Local Government (CLG) communities, and **seventy-five (75)** calendar days before a Review Board meeting for non-CLG communities. This schedule allows for final SHPO review, SHPO notification to required parties in accordance with federal regulations, and transmittal to the board. Deadline dates above are for **complete** nominations, **not drafts**.

A complete nomination package is one that has been reviewed and approved by SHPO staff and includes all items described in the [National Register of Historic Places Nomination Package Checklist](#) and the [National Register Nomination Pre-Submission Self-Review Checklist](#), both available at the National Register page of the SHPO website, www.michigan.gov/nrhp.

Nominations are generally reviewed in the order received. If a nomination arrives on a deadline date and is not complete, it will not be placed on the review board meeting agenda. Complete and accepted nominations received by SHPO are scheduled for the first possible meeting of the board, unless the agenda is full, in which case the completed nomination will be placed on the agenda of the subsequent meeting.
