I. General Information

The State of Michigan has been awarded \$43,570,000 in federal funding to recover from Michigan’s 2024 Severe Storms, Tornadoes, and Flooding (DR-4757-MI). The funds are provided by the U.S. Department of Housing and Urban Development (HUD) through the Community Development Block Grant Disaster Recovery (CDBG-DR) Program. The CDBG-DR Program helps rebuild areas affected by disasters by providing flexible funding to assist with recovery from Presidentially declared disasters, addressing unmet needs for long-term recovery.

II. Proposed Allocation of Funds

MEDC plans to incur pre-award administrative costs prior to submitting a Public Action Plan in DRGR, which includes procurement of professional services contract to assist in the development of the Admin Action Plan and the Action Plan (when applicable), Marketing and Outreach for the Action Plan development and amendments, and other similar items. The estimated budgeted amount of the pre-award funds to accomplish these tasks is \$2,178,500. The remaining balance of the administrative funds is for CDBG-DR eligible program administration expenses throughout the life of the grant.
