## **CLG TRAINING AND CONTINUING EDUCATION**

EXAMPLE RESOLUTION

This example has been provided for the benefit of Certified Local Governments (CLG) applying for funding support for training and continuing education. Resolutions do not have to match the example word-for-word but must include the major components, including the identification of the attendee/event, the funding request, acknowledgement that this is a reimbursable grant program, and the name of the person authorized to execute the grant agreement and related documentation.
