

WHAT IS THE IIJA?

The once-in-a-lifetime investment for transportation and infrastructure including \$973 billion over five years from FY 2022-FY2026 as well as \$550 billion in new investments for all modes of transportation, clean energy, water, broadband, resilience, and more. Most IIJA resiliency funding will become available in Fall 2022 or late FY 2022. Track funding opportunities here.

HOW DO YOU PREPARE FOR THIS **FUNDING?**

- 1. Incorporate resiliency into IIJA projects you may already be doing in your community.
 - The end goal is that resilience and the ability to respond to a changing climate will be built into all aspects of the community from infrastructure (bridges in good conditions) to ensuring people are safe from climate impacts (such as heat waves).
 - Ex: Incorporate green stormwater infrastructure or improved non-motorized paths or lanes.
- 2. Identify potential resiliency projects,
 - Use the Resiliency Self-Assessment from the MEDC Resiliency Toolkit to kickstart this selection process. Engage with local stakeholders to assist in this.
- 3. Reach out to the appropriate regional offices for state and federal agencies that will be overseeing programs with funding to establish relationships.
- 4. Enroll in Grants. Gov & continue to monitor resources and agencies for when funding may become available! (Select the IIJA category on Grants.gov)
